Code of Conduct / Compliance

As part of our initiative to safeguard compliance with our Code of Conduct we, amongst others such as e.g. regular site visits by management, identify and mitigate the risk of slavery and human trafficking in our supply chain by giving regular training to our staff to ensure high level of understanding of the risks of modern slavery and human trafficking in our supply chains and our businesses.

Our effectiveness in combating slavery and human trafficking

We do not have key performance indicators specifically in relation to slavery or human trafficking as any instance would constitute a breach of our Code of Conduct which is an integral part of any employment arrangements within our group. In relation to our own employment practices, we monitor and review:

The number of employees who have completed Code of Conduct compliance training;

Any issues raised through public interest disclosure; and

The independent compliance hotline.
